Wu Xiaohua, Deputy Secretary of the Party Work Committee, Lin-gang Special Area Administration Committee, Shanghai Pilot Free Trade Zone, introduced the integrated circuit industry in the Lin-gang Special Area. The Lin-gang Special Area serves as a frontier base for Shanghai's deep connection to global markets, with integrated circuits being one of its five core strategic industries. Over the past five years, the Lin-gang Special Area has signed agreements with a total investment of RMB 260 billion, attracting 300 integrated circuit companies in various fields including chip design, manufacturing, materials, equipment, packaging and testing, and core components. In the future, the Lin-gang Special Area will focus on key areas such as wafer manufacturing, packaging and testing, core equipment, and critical materials. It will provide services and support by emphasizing institutional and technological innovation while accelerating the modernization of the new area to drive the high-quality development of the integrated circuit industry.

Yin Jianguo, Chairman of Suzhou Industrial Park Biotech Development Co., Ltd. (BioBAY), introduced the biopharmaceutical industry in the Suzhou Area of China (Jiangsu) Pilot Free Trade Zone. The Suzhou Area boasts a complete industrial chain, covering upstream and downstream sectors such as raw materials, equipment, consumables, process purification, CDMO, CRO, and more. In addition, it is equipped with research institutions, hospitals, clinical organizations, regulatory bodies, academic institutions, creating a mature biopharmaceutical industry ecosystem. As of now, the Suzhou area is home to over 2,000 biopharmaceutical companies, with an output value of RMB 150 billion. Among them, the top seven of the world's top 20 pharmaceutical companies and 11 of the world's top 20 medical device companies have set up factories or R&D centers in the Suzhou Area.

Li Xiaoyan, Deputy Director-General of the Department of Commerce of Hubei Province, introduced the optoelectronic information industry in the Wuhan Area of China (Hubei) Pilot Free Trade Zone. The Wuhan Area has consistently focused on building industrial clusters and continuously improving scale and quality. It is the largest optical fiber and cable production base in the world, the largest optoelectronic devices production base in China, an R&D and production base for small and medium-sized display panels. In 2023, the production of optical fiber and cables in the Wuhan Area accounted for about 50% of the national market and 25% of the global market. The international market share of optoelectronic devices exceeded 12%, while laser equipment types accounted for more than 70% of the domestic market. Additionally, the Wuhan Area holds a global market share of approximately 24% for small- and medium-sized low-temperature polysilicon display panels.

Liao Guanghui, Deputy Director-General of the Department of Commerce of Hunan Province, introduced the construction machinery industry in the China (Hunan) Pilot Free Trade Zone. Hunan's construction machinery products cover 12 major categories, more than 100 subcategories, and nearly 500 models, accounting for approximately 70% of the national market share. Products manufactured by Hunan enterprises, including concrete machinery, construction hoisting machinery, excavation machinery, piling machinery, and tunnel boring machinery, lead the country in both production and sales. Among them, concrete machinery, excavators, construction hoists, and full-face tunnel boring machines rank first in global sales. Hunan has focused on strengthening, solidifying, extending, and complementing the construction machinery industry chain, creating a comprehensive industrial chain that includes model design, key component supply, system assembly, equipment assembly, product marketing, service support, and remanufacturing.

Qin Shubin, Deputy Director-General of Chongqing Liangjiang New Area Administrative Committee, introduced the intelligent connected new energy vehicle (NEV) industry. As one of the first PFTZs in the western region, China (Chongqing) Pilot Free Trade Zone, covering only 1.46% of the city's area, contributes 60% of the city's total foreign trade import and export value and 50% of the actually utilized foreign investment, playing a key role in Chongqing's development as an inland open comprehensive hub. Liangjiang New Area is the main hub for the development of Chongqing's automobile industry and is home to nine automobile manufacturers, including Changan, Seres, AITO, and Avita, as well as over 200 core component suppliers. It has established a fund system that integrates seed, angel, VC, PE, and FOF funds, providing relay-style financial services and creating a new ecosystem for the intelligent connected NEV industry. Leveraging the multimodal transport advantages of Guoyuangang Area, Liangjiang New Area has launched rail-sea intermodal trains for new energy vehicles, opening a green cross-border export channel.
