迈克尔·莱维特博士，1947年5月9日出生于南非比勒陀利亚，美国和英国双重国籍，生物物理学家，2013年诺贝尔化学奖获得者，美国斯坦福大学结构生物学系终身教授。迈克尔·莱维特在计算生物学领域有着杰出的造诣，是最早指导DNA和蛋白质分子动力学模拟的学者之一。

Dr. Michael Levitt, born May 9, 1947, in Pretoria, South Africa, holds dual citizenship in the United States and the United Kingdom. As biophysicist and Nobel Laureate in Chemistry of 2013, he is a tenured professor in the Department of Structural Biology at Stanford University. Michael Levitt has made outstanding contributions in computational biology and was among the earliest scholars to pioneer molecular dynamics simulations of DNA and proteins.
