上海市副市长宗明,商务部党组党员、部长助理任鸿斌,联合国工发组织执行干事伯纳德·卡尔扎德拉·萨尔门多和中新社总编辑王晓晖致欢迎词。张文宏、周延礼、蔡江南、曾光、卢清君、齐贵新、宋为群、安思嘉等多位顶级专家跨界思想碰撞,共话健康中国。

11月6日,第三届中国国际进口博览会召开之际,由国家药品监督管理局、中国国际进口博览局主办,上海市药品监督管理局、中国医药保健品进出口商会和中国国际进口博览会参展商联盟公共卫生防疫专业委员会共同承办的"中国药械化妆品监管政策交流会"降重召开。

商务部党组副书记、副部长、国际贸易谈判副代表 俞建华,国家药品监督管理局副局长颜江瑛出席会议 并致辞。来自商务部、国家药监局、国家医保局、相关 省市药监局以及海内外药械化妆品企业、海外驻华 机构及新闻媒体130余位代表参加了大会。

交流会分为开幕式、政策解读、产业代表发言三个环节。开幕式和政策解读环节由国家药监局科技和国际合作司司长秦晓苓主持。

颜江瑛在致辞中指出,中国作为药品、医疗器械、 化妆品生产大国和使用大国,在受益于医药产业快速 发展的同时,也面临着医药产业新科技高速发展带来 的重大机遇和巨大挑战。新冠肺炎疫情发生以来,国家 药监局毫不放松做好疫情防控工作,不断优化工作 流程,集中药监力量跑出了"中国速度",为中国抗疫 斗争取得重大战略成果作出了积极贡献,为全球疫情 防控提供中国助力。她真诚欢迎全球优秀的药品医疗器械化妆品企业来到中国,把最先进、最优质的产品带入中国广阔的市场,共享中国发展的新机遇;国家药监局也希望业界同仁为中国药品监管和医药产业创新发展建言献策。

俞建华在致辞中表示,新冠肺炎疫情大流行给各国带来严重冲击。在国务院联防联控机制统一领导下,商务部会同相关部门,采取严把医疗物资出口质量、规范非医用口罩出口秩序、加大出口执法力度等措施,加强防疫物资出口监管,有序推进医疗物资商业出口。中国已是世界最大的医药健康产品生产制造和出口国,也是最主要的医药健康产品消费市场,发展前景十分广阔。希望中外企业抓住机遇,顺势而为,共同推动医药健康产业发展。

在政策解读环节,来自国家药监局药品注册司 杨胜副司长、药品监管司崔浩副司长、医疗器械注册司 王兰明专员、医疗器械监管司王者雄司长、化妆品监管司 李金菊司长和科技和国际合作司秦晓岑司长分别发言, 围绕当前药品、医疗器械和化妆品的监管政策和思路 进行了详细权威的解读。来自国家医保局医药服务 管理司的熊先军司长介绍了中国现行的医疗保障制度。



医保商会党委书记、副会长孟冬平主持了产业界代表发言环节。她在引导发言中表示,突然爆发的疫情凸显了医药监管政策在守护生命健康、维护行业有序发展、促进进出口贸易顺畅等方面所起的至关重要的保障作用。制度和服务的创新,正在深深地影响改变着市场的发展态势,推动着产业的良性发展。越来越多的海内外企业积极参与中国改革开放,为促进行业的健康可持续发展贡献着智慧和力量。

武田制药全球高级副总裁单国洪、罗氏诊断中国区总经理姚国樑、欧莱雅中国总裁兼首席执行官费博瑞、再鼎医药创始人、董事长杜莹博士分别代表医药、医疗器械、化妆品海外企业和本土创新药企业发言,表达对中国政府药械监管政策持续改革,与国际接轨的高度赞赏和对中国市场前景的信心。

The Meeting on Drug, Medical Device and Cosmetic Regulation in China was held in Shanghai on November 6 during the 3rd China International Import Expo (CIIE). The meeting was hosted by National Medical Products Administration (NMPA) and the CIIE Bureau, and co-organized by Shanghai Medical Products Administration, China Chamber of Commerce for Import and Export of Medicines and Health Products (CCCMHPIE) and the Public Health and Epidemic Prevention Committee of the CIIE Enterprise Alliance.

Yu Jianhua, Deputy Secretary of the CPC Leadership Group, Vice Minister and Deputy China International Trade Representative of MOFCOM, and Yan Jiangying, Deputy Commissioner of NMPA, attended and addressed the meeting. The meeting attracted 130 participants, including the delegates from the Ministry of Commerce of (MOFCOM), NMPA,

National Healthcare Security Administration (NHSA), provincial-level medical products administrations, and pharmaceutical, medical device and cosmetic companies from home and abroad, and offices of overseas institutions in China, as well as media representatives.

The meeting consisted of the Opening Ceremony, Policy Interpretation and Industry Voice. The former two sessions were moderated by Mr. Qin Xiaoling, Director General of the Department of Science, Technology and International Cooperation of NMPA.

In her address, Yan Jiangying pointed out that China, as a big producer and consumer of pharmaceuticals, medical devices and cosmetics, is not only benefiting from the rapid growth of the industry but also facing major opportunities and challenges brought about by the development of new technologies in this field.

Since the outbreak of COVID-19, the NMPA has spared no efforts in pandemic prevention and control. Through optimizing work processes and mobilizing resources of NMPA to contribute Chinese Wisdom with Chinese Speed, NMPA has made positive contributions to the anti-pandemic fight in China and across the world.

Yan Jiangying said that the NMPA sincerely welcomed the world's outstanding pharmaceutical, medical device and cosmetic enterprises to China, bringing their most advanced and high-quality products to the vast Chinese market and embracing



new opportunities from China's development. The NMPA also seeks for advice from the industry for China's drug regulation and the innovative development of the pharmaceutical industry.

Yu Jianhua expressed in his speech that the pandemic has caused serious impacts on countries and regions across the globe. Under the leadership of the joint prevention and control mechanism deployed by the State Council, the MOFCOM has taken diverse measures to enhance anti-pandemic materials export regulation and orderly promote the commercial export, such as supervising export quality, regulating export order of non-surgical masks, and enhancing export enforcement. As the world's largest pharmaceutical and healthcare product manufacturer and exporter, China is also a major consumer market for these products. The prospects for the industry are broad. It is hoped that domestic and overseas enterprises could seize these opportunities, follow the trend, and jointly promote the development of the pharmaceutical and healthcare industry.

In Policy Interpretation, six delegates from NMPA, including Yang Sheng, Deputy Director General of Department of Drug Registration, Cui Hao, Deputy Director General of Department of Drug Regulation, Wang Lanming, Inspector General of Department of Medical Device Registration, Wang Zhexiong, Director General of Department of Medical Device Regulation, Li Jinju, Director General of Department of Cosmetics Regulation, and Qin Xiaoling, Director General of Department of Science, Technology and International Cooperation, gave official interpretation on the current regulatory policies and thinking on drugs, medical devices and cosmetics. Xiong Xianjun, Director General of Department of Drug Service Management of NHSA, introduced the current healthcare security system in China.

Meng Dongping, Secretary of the Party Committee and Vice President of CCCMHPIE, moderated the



Industry Voice Session. In the introductory speech, she remarked that amid the sudden outbreak of the COVID-19 pandemic, drug regulatory policies play a critical role in protecting lives and public health, ensuring the steady development of the industry, and promoting the smooth functioning of import and export. The system and service innovation is profoundly influencing the market development trend and propelling the benign development of the industry. More and more domestic and overseas enterprises have engaged in China's reform and opening up and contributed their wisdom and strength to the healthy and sustainable development of the industry.

Four guest speakers from domestic and overseas enterprises of innovative drugs, medical devices and cosmetics, including Sean SHAN, Senior Vice President of Takeda Pharmaceutical Company Ltd, Kwok Leung Yiu, General Manager of Roche Diagnostics (Shanghai) Limited, FABRICE MEGARBANE, President and CEO of L'Oréal China, and Samantha Du, Founder, Chairwoman and Chief Executive Officer of Zai Lab, delivered speeches on industry innovation and development, expressing high praise for China's continuous reform in medical device regulatory policies and strong faith in China's market prospects.

11月6日下午,由国家药品监督管理局和中国国际进口博览局共同主办,上海市药品监督管理局、中国国际进口博览会参展商联盟公共卫生防疫专委会、中国医药保健品进出口商会承办的中国药械化妆品监管圆桌对话会在国家会展中心(上海)成功举办。国家药品监督管理局科技和国际合作司、药品注册司、药品监管司、医疗器械注册司、医疗器械监管司、化妆品监管司,上海药品监督管理局领导,进口博览局财务总监马凤民出席本次会议,中国医药保健品进出口商会党委书记孟冬平主持。

会议邀请雅培、罗氏、默克、飞利浦、阿斯利康、 艾伯维、美敦力、强生、欧莱雅、联合利华、资生堂等 知名企业分别围绕药械审评审批模式、境内外生产 监管与场地转移、化妆品创新发展等议题发言并展开 讨论。

作为第三届进口博览会政策解读类配套活动之一,本次会议通过搭建药械化妆品行业政企高端对话平台,有利于各方深入探讨交流药械、化妆品改革的思路和进展,助力境外企业开拓中国市场,共同推动进博会"越办越好"。

On the afternoon of November 6, 2020, the Roundtable on Drug, Medical Device and Cosmetic Regulation in China was successfully held at the National Exhibition and Convention Center (Shanghai). 

After people's active application for participating in CIIE and the careful preparations of the relevant personnel of CIIE in the earlier stage, the "Signing Ceremony of the Centralized Procurement for Large Medical Equipment of Municipal Hospitals in Shanghai and New Medical Equipment Launch Event" was held at the site of the CIIE on the morning of November 8. It was attended by leaders from Shanghai Municipal People's Government and relevant committees, offices, and bureaus, as well as the Hospital Development Center (Shanghai). The attendees also included nearly two hundred representatives from municipal hospitals, imported equipment manufacturers, imported equipment agents, and media. At the ceremony, representatives of 16 municipal hospitals and five bid-winning

enterprises and bidding agencies were organized to sign contracts for 28 large medical equipment purchased through centralized bidding in 2020. Six enterprises launched new products, and eight municipal hospitals and a number of export manufacturers signed their intention agreements on the spot. 11月9日,由上海市民政局、青浦区人民政府、东浩 兰生(集团)有限公司联合主办的2020国际康复辅助 器具产业创新论坛在国家会展中心(上海)举办。作为 第三届进博会的配套活动之一,论坛聚集了政府部门、 业内专家、相关高校、企业家、投资人等近百名嘉宾 到场,万余名观众观看了直播。

上海市民政局局长朱勤皓回顾了"十三五"期间本市在推动康复辅具产业的发展成果,同时提出"十四五"本市加快发展康复辅具产业前瞻思考:一是探索形成多元化的康复辅具支付体系;二是加快科技创新和成果转化,推动形成具有完整产业链的康复辅具产业集群;三是完善康复辅具标准体系和目录制度;四是建立康复辅具咨询师队伍;五是三省一市共同建设"康复辅具产业园";六是培育康复辅具消费市场,推进无障碍交流康复辅具在公共服务领域的应用。

启动。上海市民365科普秀也在现场进行了展示,将以 互动科普方式打通消费端与产业端,联动长三角,挖掘 高性价比产品和意见领袖,促进创新技术应用,落实 康复辅具产品、服务进社区、进家庭。 An international rehabilitation aids industry forum (RAIF) was held by Shanghai Civil Affairs Bureau, People's Government of Qingpu District of Shanghai Municipality and Donghao Lansheng(Group)Co.,Ltd on Monday at the third China International Import Expo, with officials, experts, professors and business representatives sharing views of how the industry will develop.

"Shanghai will establish a diversified payment system for rehabilitation devices combining various insurance means such as long-term nursing insurance targeting the elderly, medical treatment insurance and commercial insurance," Zhu Qinhao, director of the Shanghai Civil Affairs Bureau, told the International Rehabilitation Aids Industry Innovation Forum.

The city will also research including rehabilitation devices in the city's medical insurance reimbursement system, said Zhu.

Authorities will encourage commercial insurance companies to develop financial products catering to rehabilitation device suppliers. Shanghai will also establish a database on intellectual property rights and promote integration of 5G technology and the rehabilitation industry, said Zhu.

The city also plans to establish a team of 10,000 consultants in rehabilitation device technologies, Zhu

said. Regular experience activities will be conducted, enabling residents to experience the world's latest devices. A rehabilitation device industrial park of the Yangtze River Delta region is on the agenda, he said.

The consumption market of rehabilitation aids in the Yangtze River Delta is an opportunity for Both Chinese and international enterprises. Standing at the end of the 13th Five-Year Plan and the important moment of planning the 14th Five-year Plan, the "Rehabilitation Aids Industry 100 Billion Club of the Yangtze River Delta "was officially launched under the witness of Shanghai Civil Affairs Bureau, Qingpu District People's Government, Jiangsu Provincial Civil Affairs Department and Anhui Provincial Civil Affairs Department.

The 365 days' Popular Science Show was also presented at the forum. It is understood that the show will connect the consumer and industry by means of interactive science popularization, and promote the rehabilitation aids and related use methods in the "entertainment of daily necessities". In conjunction with the Yangtze River Delta, we will explore cost-effective products and opinion leaders, promote the application of innovative technologies, and ensure that products and services of rehabilitation AIDS are introduced into communities and families.
